RICHMOND COUNTY 2026 HEAVY GARBAGE COLLECTION SCHEDULE

May 4 – May 30/ 2026

A **Heavy Garbage Collection Program** will be carried out in Richmond County from May 4 to May 30, 2026. Waste should be placed curbside by 8am on Monday of the scheduled collection week for the area; items placed at the curb after collection has started in the area may not be collected.

Week 1 (May 4 – 10) – Collection Zone 1 (Isle Madame)

- Isle Madame

Week 2 (May 11 - 17) – Collection Zone 2 (Areas West of the St. Peter's Canal, excluding Isle Madame)

- St. Peter's, River Bourgeois, Louisdale, Grand Anse, Lennox Passage, Dundee, St. George's Channel, Sampsonville, Black River, Oban, Seaview, Evanston, Lower River, Whiteside, Kempt Rd., and Point Tupper.

Week 3 (May 18 - 24) – Collection Zone 2/3

- Any remaining areas in Collection Zone 2 (noted above)

Collection Zone 3: Fourchu, Framboise, Grand River, Point Michaud, Lower L'Ardoise, L'Ardoise to St. Peter's, Johnstown, Loch Lomond to St. Peter's, and remaining portions of Richmond East of St. Peter's Canal.

Week 4 (May 25 – May 30) – Collection Zone 3 (Areas East of the St. Peter's Canal)

- Any remaining areas in Collection Zone 3 (noted above)
