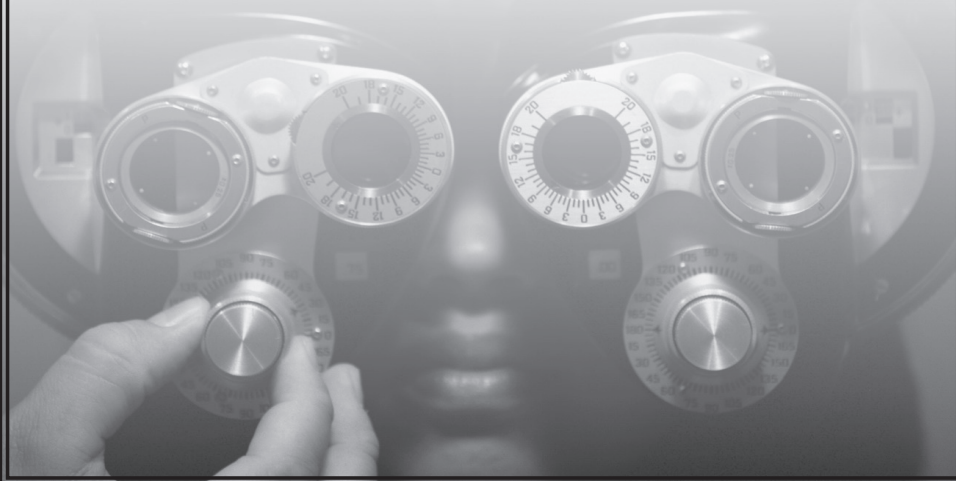

Joint Police Advisory Board for the Municipality of the County of Inverness, the Town of Mulgrave, and the Town of Port Hawkesbury

The Town of Port Hawkesbury is seeking one member of the public to serve on the Joint Police Advisory Board for the Municipality of the County of Inverness, the Town of Mulgrave, and the Town of Port Hawkesbury, (the "Joint Police Advisory Board"). The appointment term is 4 (four) years.

The purpose of the Joint Police Advisory Board is to provide advice to the Councils of the Municipality of the County of Inverness, the Town of Mulgrave, and the Town of Port Hawkesbury in relation to the enforcement of law, the maintenance of law and order, and the prevention of crime in their respective municipal units.

Volunteer Qualifications:

- (a) Resident of the Town of Port Hawkesbury (*Note: Councillors and employees of the Municipality of the County of Inverness, the Town of Mulgrave, or the Town of Port Hawkesbury are ineligible*);
- (b) Considerable knowledge of community issues and an understanding of policing values and governance;
- (c) Good character;
- (d) Consent to criminal and background checks (*Note: an applicant will be ineligible if criminal and background checks show that the applicant has been convicted of any criminal offence or has been or is the subject of a disciplinary proceeding in any jurisdiction that, in the opinion of the Council of the Town of Port Hawkesbury would reasonably be expected to have a negative impact on their acting as a member of the Joint Police Advisory Board*); and
- (e) Willingness to:
 - make the commitment of time and effort required to carry out responsibilities of the Joint Police Advisory Board; and
 - take the oath of office or affirmation and abide by the code of conduct required by the *Police Act* and its regulations.
